	Our audited financial statements for the 2024 financial year are available here today and have been prepared by APW Accountancy Plus Whitsunday. As shown in this report, the income for the Chamber is \$59,412 well up on last year due to merger funds from the Proserpine Chamber of Commerce and increases in membership and event sponsorship. You will note our expenditure however is far higher on last year, as the Chamber Board chose to invest in resources in our Chamber Liaison role. We have generated a surplus of \$7,863 and have a healthy bank balance of \$30,152.44 as of yesterday.
